I want to thank each one of you for your dedication and commitment to our mission. Your unwavering support is what makes it possible for us to continue to make a difference in the lives of those we serve.



A MINISTRY OF CATHOLIC CHARITIES

We join our co-workers at Cardinal Ritter Senior Services in thanking Archbishop Mitchell Rozanski for making the time to bless the new memory care community at the open house for the Michael Community (named for the Archangel Michael). This older adult community for the especially vulnerable group with memory care issues, is a beautiful place to care for those in need. Also, this assisted living community is the only certified care center in Missouri using the Positive Approach to Care through the internationally renowned dementia care expert, Teepa Snow.







A MINISTRY OF CATHOLIC CHARITIES

At our ministry, **Queen of Peace** Center, the Nurturing Networks Therapeutic Childcare Center provides diverse services to children who have a mother actively engaged in treatment and fall between six weeks and five years of age. This early



intervention and prevention program offers social and emotional support in a therapeutic classroom setting. The teachers are there every step of the way to provide a safe and caring environment in order for the children to learn and grow. A typical day starts with making sure the children are acclimated to the learning environment and feel safe. The Early Childhood Center is set up to give positive re-enforcement from the teachers to build confidence and provide love.

At 37, Cierra found herself in challenging times pregnant with her third child, in a demanding job, and just needing help. Feelings of doubt about her ability to be successful with this pregnancy and parenting her children left her feeling alone. Cierra turned to our ministry, Good Shepherd Children & Family Services to find support, information, and resources so she could learn how to take care of both her family and herself. With the help of her counselor, Cierra gave birth to a healthy baby girl and continues to work full-time. She and her family live together working through it all. As Cierra says herself, "Good Shepherd



gives you the good tools and knowledge you need for pregnancy, to care for a newborn and to take care of yourself."



Saint Martha's is Catholic Charities ministry that offers shelter and support services for women and children impacted by domestic violence.

A few weeks ago, Saint Martha's met with a woman who had stopped by the Drop-In Center of this ministry fleeing an extremely violent situation with her child. The client needed resources, including legal services, as she was in a custody situation for her child. Saint Martha's reached out to **Catholic Legal Assistance Ministry (CLAM)** with St. Francis Community Services and secured a family law attorney for help with court proceedings.

Very soon after, the CLAM attorney and an advocate from Saint Martha's went with this client to court to face the situation and be with her as the client faced her abuser. With the help from all, the client was able to establish a temporary custody order that helped protect both the woman and her child. This collaboration within the ministries of Catholic Charities will continue for this woman and her child until a secure, safe, long-term custody order is in place and both are safe. There is no doubt the advocates from Saint Martha's and the attorney for CLAM changed the trajectory of this mom and child's life.



A MINISTRY OF CATHOLIC CHARITIES

Former Army Specialist Milano has been a client in two Catholic Charities programs at St. Patrick Center. He has worked with the Supportive Services for Veteran Families program (SSVF) and Homeless Veterans Reintegration Program (HVRP) for over one year now and has worked very hard to get where he is today. Milano came into the program five days sober, staying in a shelter and with a deep desire to become a better provider for his family. Milano showed a deep commitment to the programs at St. Patrick Center, making all his appointments and abiding by all program guidelines. He was quick to admit mistakes, willing to ask for help when needed and always willing to put in the hard work needed to succeed. Through the HVRP, Milano was able to find permanent housing and obtain a stable job. He has since been promoted to general manager

at his current employer, is more than one year sober and is enjoying housing stability.

Saint Louis Counseling therapists are often asked, "What is the difference between mental health and mental illness?" In simple terms: Everyone has mental health—it's as important as our physical well-being. But with one in five adults diagnosed with a mental illness, it touches the lives of likely everyone we know. Stigma around mental illness still exists, making it difficult for some to seek treatment. Yet, there's no need to be afraid.

With professional and compassionate counseling, people of all ages with mental-health conditions and mental illnesses can, and do, live full and happy lives. When we break down the stigma by helping others understand that mental health is as important as physical health, more people will



get the counseling they need. Together, let's respond with hope and healing.

Our ministry, LAMP (language, access, multicultural, people) sometimes gets called into difficult medical situations as translators. In a recent incident, Mid-America Transplant reached out to the call-in center to help with a family who was dealing with the loss of their daughter and about donating to the transplant organization. The challenge of explaining the medical jargon and the emotional content made it even more difficult than normal; however, the LAMP interpreter demonstrated a remarkable level of professionalism, precision, and empathy for the family. The interpreter's contribution was vital

in helping the family's ultimate decision to donate, thus providing the gift of life to others.
